

**ALABAMA BOARD OF NURSING
BOARD-RECOGNIZED TREATMENT PROVIDERS**

All nurses who need treatment for a substance use disorder must be evaluated by a physician with expertise and experience in treating these disorders. Many treatment programs include evaluation by a physician as part of the comprehensive nature of their services. These programs are listed in the section immediately following this information.

If you wish to go to treatment at a program that DOES NOT include physician evaluation, you must complete an evaluation with a Board-approved physician. The evaluation must be arranged by referral from the Board of Nursing.

The following nurses must consult with the Nurse Consultants in the Legal Division PRIOR to completing any evaluations:

1. Nurses seeking Reinstatement of a Revoked License;
2. Nurses with Consent/ Board Orders;
3. Nurses who DENY there is a problem with substance use/ abuse are required to go to specific providers for their evaluations.

Evaluations that are obtained PRIOR to Board consultation are NOT ACCEPTED.

Purposes of the Evaluation

- Determine appropriate level of care required for treatment.
- Assessment of entire client, not simply the substance use disorder.
- Accurate diagnosis according to industry acceptable criteria for substance use disorders.

Treatment Programs that Include Evaluation by a Physician

If you begin treatment with any of the programs included in this section, assessment by a Board approved physician is included. This physician, along with the treatment team, will determine the appropriate level of treatment for your problems. You may go to any of these providers without a separately arranged evaluation through another physician.
